WILD DUCK FEEDING BAN & EDUCATION PLAN

Committee Chair Rielly gave the floor to Ms. Leavitt and Leah Cromarty, a Girl Scout and student at Westbrook Middle School. Ms. Cromarty is working toward achieving the Silver Award, in which a scout completes a project that makes a sustainable and lasting difference in the community. Ms. Cromarty stated that she wishes to work with the Public Services Department to install signs at Riverbank Park asking people not to feed the wildlife, specifically ducks. Ms. Cromarty and Ms. Leavitt discussed the negative effects that feeding ducks and other animals can have on the animals' health and on the environment.

When the contamination reaches a certain level, the entire truck load of recycling must be dumped as garbage, at the City's expense. Ms. Leavitt is currently exploring options to reduce recycling contamination, including issuing warnings to eliminating an offender's recycling bin.

SOLICITING FEEDBACK ON PROPOSED USE CHANGE FOR GAS STATION IN CITY CENTER DISTRICT

Existing gas stations in this district are considered non-conforming uses, meaning they are not allowed to update or expand their operations. Amending the Land Use Ordinance would allow for additional investment in these properties. This matter is being brought forward to Committee to see if there is any Council interest in pursuing this Ordinance amendment. If so, staff would proceed to draft an ordinance allowing limited gas stations in the City Center District and would present it to the Planning Board and ultimately Council for approval. If there is no Council interest in this matter, staff would not take any further action.
